The April 3, 2018, meeting of the Maryland Board of Public Accountancy was called to order at 9:00 am by Chairman of the Board, Arthur E. Flach.

Upon a motion (I) by Mr. Marshall, and seconded by Mr. Korb, the minutes of the March 6, 2018, meeting were approved without correction.

Chairman's Report

Chairman Flach led a discussion on firm mobility and MD House Bill 1597 and its impact on the Boards ability to grant licensure to certain applicants.

There has been a great deal of legislation around the country centering on State Boards. Some of the more notable are as follows:

- Firm mobility legislation has been introduced in Iowa, Illinois, Kentucky, Massachusetts, Michigan, New Hampshire, New Jersey, and Vermont.
- Indiana Legislation Signed Into Law Limits Board's Ability to Deny Licensure Due to Past Criminal Convictions
- HB 1245 provides that the state and a local governmental unit shall explicitly list the crimes that will disqualify an individual from receiving an occupational license. It notes that a disqualifying criminal conviction is limited to a crime that specifically and directly relates to

the duties and responsibilities of the occupation for which the individual is applying for or holds a license. It also provides that the period of disqualification may not exceed five years unless the individual: (1) was convicted of a crime of violence, or an offense relating to a criminal sexual act; or (2) is convicted of a second or subsequent crime during the disqualification period. Finally, the bill stipulates that an individual having a criminal conviction may at any time petition the board or unit requiring a license for a determination as to whether the individual's criminal conviction will disqualify the individual from receiving that license.

Maryland HB 1597

- FOR the purpose of prohibiting certain departments that issue occupational licenses or
 certificates from denying an application for a license or certificate based on an applicant's
 criminal history if a certain period of time has passed since the applicant's conviction for any
 crime unless the department makes a certain determination; repealing a certain provision of
 law that requires a certain department to consider certain information in making application
 determinations for occupational licenses or certificates; providing for the application of this
 Act; and generally relating to the use of criminal history for application determinations of
 occupational licenses or certificates.
- The period would be 5 years and the board would be able to make a determination if the previous conviction would have an impact on the licensee's fitness or ability to perform the duties and responsibilities authorized by the board.

Upon a motion (II) by Mr. Mostow, and seconded by Mr. Ware, the Board unanimously approved the Chairman's Report.

Executive Director's Report

Ms. Jordan reported that the NASBA Eastern Regional is coming up on June 5-7, 2018. She is submitting scholarship requests for the new board members. She also reported that she is in the process of hiring an Assistant Director.

Upon a motion (III) by Mr. Helmstetter, and seconded by Mr. Marshall, the Board unanimously approved the Executive Director's Report.

Exam Appeals

Nothing to Report.

Education Report

Mr. Korb presented the Education Report. There was one (1) Transfer of Grades applications approved, which originated in MA. There were zero (0) Transfer of Grades denials.

Upon a motion (IV) by Mr. Mostow, and seconded by Mr. Ware, the Board unanimously approved the Education Report.

Mr. Ware presented the Firm Permit Report. There were three (3) MD firm permit application approved, zero (0) firm applications closed.

Chairman Flach led a discussion in reference to Ms. Jordan's upcoming meeting with MACPA regarding Peer Review tracking.

 CE Credit is automatically approved by NASBA registered sponsors otherwise; it must go to the
 Board for approval and will be subject to audit. There will be further discussion during Executive
 Session to determine the process for review.

Upon a motion (VIII) by, Mr. Mostow, and seconded by Mr. Ware, the Board unanimously approved to discuss the process for review of CE Credit Approval.
