#### **OLD BUSINESS**

Paul Edmeades briefed the Board on the New Zealand/Australia MRA and noted that the Board voted to approve the MRA at the NCARB Annual Meeting in June 2016. He stated that NCARB has determined that New Zealand and Australia have equivalent requirements for licensure. Milena Trust stated that the Board should not approve the MRA because these countries do not require examination for licensure. She stated that the Board would not be violating Maryland law if it voted to approve the agreement but it would not be fair to US citizens who are required to pass the ARE.

A motion (IV) was made by Gary Ey, seconded by Magda Westerhout to approve the MRA. The motion carried by four Board members voting to approve and one voting to disapprove the MRA.

The Board decided to discuss the issue of foreign degrees at a future Board meeting.

#### **NEW BUSINESS**

Paul Edmeades nominated Cynthia Shonaiya as Vice-Chairman of the Board. A motion was made by Magda Westerhout, seconded by Kevin Sneed and unanimously carried to approve Cynthia Shonaiya as the Vice-Chairman of the Board.

Noting the Exceptions Hearing scheduled for the next Board meeting, Paul Edmeades requested written instructions on the procedure. Susan Cherry will provide instructions on proper procedure for the hearing.

The Board briefly discussed the Tri-National Agreement (Mexico-Canada-USA). A motion (V) was made by Cynthia Shonaiya, seconded by Kevin Sneed and unanimously carried to designate Paul Edmeades as the individual authorized to sign the agreement.
