**CALL TO ORDER**

# **APPROVAL OF MINUTES**

# INCIDENT COMMITTEE REPORT

Mr. Kassel informed that the Incident Committee met before the Board Meeting to discuss incident number 02-BP-21. He informed the Board that the Committee is waiting for the Coast Guard investigation. Motion (II) was made by Mr. Reagoso, seconded by Capt. # PILOT COMPLEMENT REPORT

Captain Nielsen reported the following:

Arrivals – Up by 12% YTD.

Shifts – Up by 28% YTD.

Cargo – Unavailable

Retiring Pilots – Anticipate two (2) retiring this year.

Proposed Pilot Complement – Captain Nielsen suggested bringing in more apprentices in order to keep up with retirees. Since hiring two (2) pilot trainees as of July 1st, he recommended not to take action on starting new Pilots in training at this time.
