CALL TO ORDER

APPROVAL OF MINUTES

Motion (I) was made by Mr. Chenowith, seconded by Mr. Kassel, and unanimously carried by the Board to approve the Minutes of the January 8, 2021 meeting, without correction.

INCIDENT COMMITTEE REPORT

Mr. Kassel informed the Board that the incident committee met to discuss one open complaint and decided to close it without further action since no violation was found.

Motion (II) was made by Captain Nielsen, seconded by Mr. Steeves, and unanimously carried by the Board to approve the Incident Committee Report.

PILOT COMPLEMENT REPORT

Captain Nielsen reported the following:

Arrivals – Down 6% YTD.

Shifts – Even YTD.

Cargo – the graphs show data from 2019, as 2020 data is unavailable.

Retiring Pilots – Anticipating 6 retiring this year.

Proposed Pilot Complement – Captain Nielsen recommended starting two new PITs on July 1

PIT Selection Committee

Mr. Cullingford briefly discussed the PIT selection process. He further explained that December 31, 2021 will be the cut-off date for applicants. Since reviews and interviews will be scheduled in summer of 2022, applications are still being accepted at this time.
