#### **COMMITTEE REPORTS:**

- Education and Legislative Demetria Scott, Chair
  - For the month of April 2022, PSI administered 1338 salesperson and 58 broker exams, compared to 1219 salesperson and 54 broker exams in April 2021.
  - Education committee met this month but not enough members to make any decisions.
  - Members of the staff and commission met with PSI earlier this month for the exam review and rewrite.
  - Legislative committee still working of items.

#### **COMMENTS FROM EXECUTIVE DIRECTOR:** reported by Jillian Lord, Asst. Exec. Dir.

- Current license count totals 49,515 of which 4,190 are brokers, 3,047 are associate brokers and 41,422 are salespersons, 156 are reciprocal brokers, 71 are reciprocal associate brokers, and 629 are reciprocal salesperson. Inactive total was not reported. There are 772 branch offices.
- Mr. Kasnic would still like the Commission to consider in-person meetings. One option is only one meeting at the Eutaw Street location. Another option is two meetings; one at Eutaw Street and one at a location near BWI.
- On April 22<sup>nd</sup>, Mr. Kasnic participated in an online webinar.
- May is the last meeting for Commission Wilson.
- Elections will be held in June.
- May would have been Commissioner Johnson's last month but she will remain until a
  replacement is found. A candidate has been identified and progressing therough the process
  of being appointed.
