

# Division of Unemployment Insurance Employer Resource Guide



This guide provides information about the numerous resources available to employers and the business community, with an overview of the Maryland UI program and information on employer rights and responsibilities.

# Important Information: Maryland Employer Tax Rate Notice

Each January, Maryland employers receive notification from the Maryland Division of Unemployment Insurance (Division) about their tax rate for the upcoming year.

If you are an employer subject to unemployment insurance (UI) taxes, this notice provides information on how your tax rate is determined, your right to appeal, and resources available to you.

#### **Next steps**

- View the annual tax rate notice in the **BEACON employer portal**.
  - If you believe an error was made in computing your tax rate, you may request a review determination (within 30 days of the Date of Notice listed on the rate notice).
  - An employer can request a review in <u>BEACON</u> or by mail (see the rate notice for details). See Tax Rate and Benefit Charge Information (at <u>labor.maryland.gov/employment/uitaxexpratefaqs.shtml</u>) to learn more.

### **Employer Resources and Information**

#### 1. BEACON

employer.beacon.labor.md.gov

The BEACON UI system allows employers, third-party agents, and claimants to access information and complete several UI tasks online. Employers can submit wage reports, make payments, access correspondence, etc.

The Benefit Payment Control unit (BPC) handles fraud, claimant UI overpayments, and requests to waive overpayments.

- When a former employee applies for UI benefits, you will receive a Request for Separation Information to provide the reason for separation from employment. Submit the request via:
  - > BEACON (at <a href="mailto:employer.beacon.labor.md.gov">employer.beacon.labor.md.gov</a>);
  - > State Information Data Exchange System (at <u>uisides.org</u>); or,
  - > Mail (to the address appearing on the form).
- Mass Layoff You are required to inform the Division at least 48 hours before a mass layoff (permanent, indefinite, or temporary, which lasts seven days or more) by completing the Dislocation Event Form (at labor.maryland.gov/employment/disworkerreport.shtml).
  - > You may also complete the form to request Rapid Response support services for employers and workers amid layoffs/business closures.
- Work Adjustment and Retraining Notification (WARN) Information (at dol.gov/agencies/eta/layoffs/warn).

The WARN Act requires certain employers to provide at least 60 days' notice of plant closings and mass layoffs.

### 10. Layoff Aversion Program - Work Sharing labor.maryland.gov/employment/worksharing

Work Sharing (WS) provides an alternative to layoffs during a temporary, non-cyclical business decline (due to lower economic activity).

Through WS, employers can reduce employee hours while employees receive partial UI benefits. WS can also be used to bring back a temporarily-laid-off workforce.

# 11. Lower Appeals and Board of Appeals Divisions

Employers can appeal a determination, benefit charge, or tax rate assignment to the Lower Appeals Division. The determination will include appeal instructions (if the determination is appealable).

In Maryland, employers are required to report newly hired and re-hired employees to the Maryland State Directory of New Hires.

## 13. Maryland Workforce Exchange (MWE)

MWE is an online system that connects job-seekers and employers with employment resources. Employers can use MWE to gain exposure for job openings, recruit employees, access labor market data, find business and economic development resources, tax incentive information, etc.
