ACTION ON MINUTES

February 13, 2025, meeting minutes Approved without corrections.

NEW BUSINESS

Mr. Thomas informed the Board that an applicant, who was denied reciprocity, is requesting a hearing. The applicant obtained a professional engineer license through a PhD in Pennsylvania and Wyoming but has not passed the NCEES professional engineer exam. The Board has five months to schedule the hearing. Ms. Perrin recommended scheduling it as soon as possible.

OLD BUSINESS

Board member guidelines for application/complaint records

Mr. Venuti informed he will take up this matter at the end of the Legislative Session. There are plans to offer training after the 2025 Legislative Session.

Mutual Recognition Agreement with the United Kingdom

At the previous meeting, Ms. Perrin mentioned that the UK agreement had been presented to the Board. Mr. Thomas stated that the next step is for the Maryland Board to review and sign its intent to participate in the Mutual Recognition Agreement between NCEES and the UK Engineering Council. He also agreed to follow up with a representative from the British Embassy before the next board meeting.

CONTINUING PROFESSIONAL COMPETENCY (CPC) COMMITTEE REPORT

Mr. Farinas announced that he will be resigning from the Board by May 2025 due to his relocation to another state. Ms. Perrin expressed gratitude for Mr. Farinas' service and wished him the best. She proposed that Mr. Biswas take over as Chair of the CPC Committee, a suggestion he accepted. Additionally, she recommended that Mr. Farinas collaborate with Mr. Biswas and Ms. Meyers in approving CPC provider applications.

There were two applications approved as follows: All Star Training, Inc. and National Technology Transfer, Inc.

REPORT FROM THE ETHICS COMMITTEE

Mr. Thomas stated he will check parking and reimbursement of travel expenses prior to the next meeting.

LEGISLATIVE UPDATE REPORT

Ms. Perrin asked Mr. Venuti about the next steps, and timeline of SB529 (HB1526). Mr. Venuti indicated if the bill passes the effective date, it is October 1, 2025. He will review the board's regulations to see if any changes are necessary. The Board should have time to get this changed if applicable.

CORRESPONDENCE

Mr. Thomas stated there was correspondence dated February 26, 2025, from Patrick O'Brien. P.E., Vice President, Whitman, Requardt & Associates, LLP regarding COMAR Requirement for handwritten data with Professional Engineering Stamp. Ms. Miller asked whether they were questioning date stamping. Mr. Thomas clarified that Mr. O'Brien is specifically questioning the signee hand date of the stamp on the title block. After a brief conversation, it was agreed that the Board's reading of COMAR 09.23.03.09, a date, as well as an original signature, can be handwritten or a digital signature. However, a date affixed as part of a drawing's title block does not comply with the intent of this regulation.
