CALL TO ORDER

Robyn Dubick called the meeting to order at 1:35 p.m.

APPROVAL OF MINUTES

COMPLAINT COMMITTEE REPORT

There was no complaint committee report.

EXECUTIVE DIRECTOR'S REPORT

Joseph Cullingford provided the Board with a graph of Certified Interior Design certification trends from 2009 until 2019 the numbers have remained consistence. Mr. Cullingford informed the Board that Morgan State University is continuing to make progress with their Interior Design program and with the Council for Interior Design Accreditation (CIDA). Morgan State gaining accreditation could provide an increased number of candidates eligible for certification in Maryland.

Jessica Praley informed the Board that although the wording of the definition of Certified Interior Designers developed by the Council for Interior Design Qualification (CIDQ) was somewhat different it did not conflict with the Boards interpretation.

Ms. Praley stated to the Board their next Sunset Review would be July 1, 2024. Jesica parley and Joseph Cullingford will have advance notice.

Jessica Praley and the Board discussed the criteria they needed to observe when they looking for new Board members

There were no public comments made to the updated changes adding the Failure to Respond Regulation to the Maryland Register.

Motion (II) was made by Carmen Sneed, seconded by Cheryl Duvall and unanimously carried by the Board to accept the Maryland Register's modified language.

Jessica Praley confirmed to the Board that presenting training during an industry conference, for which CEU credit is earned, does not pose a conflict when he or she is presenting the training as an industry professional, not a member of the Maryland Board. Jessica Praley stated that she researched the matter and as long as the Board member doesn't state he or she is a Board member and does not receive payment for the presentation, there is no ethical problem.

CORRESPONDENCE

The Board was presented with correspondence concerning a question about an alternative / "equivalent" method to obtain a Maryland Certified Interior Designers Certificate without taking the NCIDQ exam. The Board responded that in order to receive a Maryland Certificate, one must a have a license or certificate in another state and apply for reciprocity. Examination waivers are only granted if an applicant meets the waiver requirements outlined in the statute.
