NEW BUSINESS

NCEES Northeast Zone Vice President Visit to the Board

Mr. Paul Tyrell, current NCEES Northeast Zone Vice President introduced himself to the Board. He is the Chairman of the MA Board for Professional Engineers as a licensed Surveyor and has been visiting other state boards. He prepared a PowerPoint presentation which included an overview of NCEES, its' vision and mission, organizational structure, products and services. He also discussed NCEES examinations, NCEES records program and the committees and tasks forces associated with NCEES. He also discussed the annual meeting being held in Washington, DC on August 14-17, 2019 and funding through NCEES

The Board members had specific questions on evaluating education, evaluation companies and Washington Accord.

CPC COMMITTEE REPORT

Motion (X) was made by Mr. Mongan, seconded by Ms. Perrin, and unanimously carried to deny the CPC provider application of Chesapeake Systems for insufficient details on the course presenter and to deny the application of VivSoft because the content of the courses being presented do not meet the criteria defined in the Continuing Professional Competency requirements in the regulations.

REPORT FROM EXECUTIVE DIRECTOR

Mr. Cullingford mentioned again to the Board that extensive repairs are being made to the building parking garage beginning August 1, 2019 and there will be no parking downstairs beginning on August 1, 2019. The Board members will either have to park at a meter in the vicinity or in a parking garage nearby. He let the Board members know that they can request reimbursement for parking by submitting an expense report.

Mr. Cullinford stated there will be a shortage of staff since Ms. Washington left as of June 28, 2019. He added that Ms. Courtney will be out for Extended leave beginning August 5, 2019. He informed the Board that staff will all assist with the PE duties.

CORRESPONDENCE

Letter from Reza Ghotbizadeh Appealing Denial to Sit for the PE Exam

Mr. Reza Ghotbizadeh submitted a letter appealing the denial of his application. After a discussion with the Civil Board member who denied the application it was determined that the application could be approved.

Email from Bryant Blake

The Board received a letter from Bryant Blake dated June 20, 2019 requesting he Board to issue him a new license due to unauthorized criminal use of his Professional Engineer's license number. A letter will be sent to Mr. Blake informing him of his new license number and when that new number takes effect.

Email Regarding ABET Accreditation Visits in MD

Mr. Cullingford received an email form Beth Mundy, Assistant to the Chief Accreditation Officer with ABET regarding ABET visits to institutions in MD by the Engineering Accreditation Commission (EAC) and Engineering Technology Accreditation Commission (ETAC) ABET Commissions this fall. They wanted to know if the Board wanted to send an observer to any of the upcoming visits. They would need to contact ABET by August 31, 2019. Ms. Perrin expressed an interest in observing at Morgan State University and Mr. Harclerode expressed an interest in observing at Frostburg State University.

Letter Regarding Clarification of Statute Concerning Exemption from Licensure

Mr. Cullingford received a letter from Robert Nichols from Declaration Networks Group, Inc. dated July 11, 2019 concerning clarification on the Maryland Code, Business Occupations and Professions §14-301 through §14-602 that requires certain organizations to have a licensed PE to perform engineering services in the State of Maryland.

Declaration Networks Group, Inc. is an internet service provider and is also designated as an Eligible Telecommunications Carrier (ETC) in Maryland. Mr. Nichols included an official letter from the State of Maryland Public Service Commission confirming Declaration Networks Group, Inc. ETC designation in the State of Maryland.

His company is claiming to be exempt to having a licensed PE on staff and is requesting a letter from the Board stating whether or not their company falls under that exemption.

The Board is requesting clarification on exactly what they are doing before they can determine if their company is exempt. The Board also needs to know if Declaration Networks Group, Inc. is a government contractor since the exemption only applies to government employees.

APPLICATIONS DENIED FOR THE OCTOBER 25, 2019 PRINCIPLES AND PRACTICE OF ENGINEERING EXAMINATION

The applicant only reported four years and six months of engineering work experience.
