# Accelerating Cyber Careers Background

- ACC is the first initiative launched through the Talent Innovation Fund (TIF), enacted by the Maryland General Assembly in 2024
- TIF is meant to increase access to high quality job training to meet skill needs in Maryland's prominent and emerging industry sectors, including:
  - Cybersecurity
  - Healthcare
  - Biotechnology
  - Manufacturing
  - Artificial intelligence
- TIF is administered jointly between the Governor's Workforce Development Board and Maryland Department of Labor.



# Accelerating Cyber Careers Background

- Goal is to bolster the talent pipeline of highly-skilled cybersecurity professionals by providing in-demand training that incorporates the use of a **cyber range**.
- Cyber Ranges are interactive, simulated platforms and representations of networks, systems, tools, and applications.
- Successful applicants will:
  - Engage stakeholders, including employer and industry partners, in curriculum and scenario development; and
  - Demonstrate that training will lead directly to employment, credential attainment, and/or advancement in the industry.
- Applicants **MUST** include detailed letters of commitment from **five** employer partners.



# Accelerating Cyber Careers Background

Applicants are responsible for developing a recruitment to placement framework, including:

- Recruitment and Screening
- Case management
- Wrap-around services
- Career Coaching
- Job Placement and Advancement

Applicants are strongly encouraged to partner with organizations to support these functions.

• Examples include Local Workforce Development Areas, Non-Profit Organizations, For-Profit Sector Businesses, Industry Associations, Local and Regional Economic Development Entities, and Registered Apprenticeship Sponsors



# Eligible Applicants

- Employers
- Institutions of Higher Education
- Tax Exempt Organizations (non-profit organizations)
- Public Agencies (units of state, local, and/or municipal government)
- Local Workforce Development Boards
- Registered Apprenticeship Sponsors
- Residents of the State of Maryland



# Funding and Period of Performance

- \$1.8M available, no funding ceiling
- Grant is based on reimbursable funding
- 36-month period of performance, with the option of 12 months for planning and 24 months of performance
- Allowable costs include:
  - Supportive Services
  - Subsidized wages
  - Grantee's administrative costs
  - Costs associated with training (capital costs associated with outfitting cyber range infrastructure, instructor costs, curriculum development, materials and supplies, certification costs, etc.)



## Priority Areas of ACC

- Serving populations typically underserved in cybersecurity
- Bridge programming for graduates of two- and four-year institutions of higher education and military
- Industry-driven programming with clear employer engagement during the development of and throughout project
- Clear and direct pathways to unsubsidized employment that provide family-sustaining wages



### Priority Areas of ACC

- Career advancement strategies including consideration of Registered Apprenticeship
- Braided or leveraged funding from public, private, and/or philanthropic funding streams and/or in-kind support
- Demonstrated willingness to provide use of cyber range for purposes other than occupational training (e.g. capture the flag events, immersion activities)
- Geographic diversity
- Regional consortiums



# Application Format and Submission

#### To be considered for grant funds, applicants must submit:

- Attachment A (Narrative)
- Attachment B (Budget)
- At least five letters of commitment from employer partners

#### **Optional**

• Letters of commitment from other entities (see Section IIC)



# Application Format and Submission

- All application materials should be submitted in a **single email** to Mary Keller (<u>mary.keller@maryland.gov</u>) by 11:59 PM on October 4, 2024.
- Attachment A (narrative) should not exceed 20 pages (letters of commitment do not count towards 20-page max)
- Attachment B may be submitted as a standalone document in native excel format.
- No template. See Section II General Provisions and Other Requirements for required information.
- Strongly encourage including prompts for clear review.



### Attachment A - Narrative

#### Narrative must include:

- Target region and geographic scope for project, including Labor Market Information
- Target population for training
- Information on employer engagement around skills gap identification, curriculum development, key uses of cyber range
- Plan for development of curricula including specific information on training
- Description of employer engagement around connecting students to employment
- Capabilities and technical specifications of cyber range
- Security posture of the user cyber range environment



### Attachment A - Narrative

- Description of how students will be recruited for training
- Detailed description of supportive services offered, including what entity will provide these services
- Past performance on a similar project
- Expected outcomes over a 36-month period of performance
- Detailed timeline for planning and implementation
- Description of how the project will infuse and advance equity
- Sustainability plan
- Description of leveraged resources used to support the project



## Supportive Services

- Assistant obtaining a driver's license
- Transportation assistance
- Uniforms, tools, related equipment this may include access to technology or internet
- Child or dependent care
- Application Fees
- Clothing for Interviews or Job Fairs
- Stipends
- Other Supportive Services deemed necessary and approved by Labor



### Performance Outcomes

Within the narrative, the applicant must identify the following:

- Total number of participants placed into training;
- Total number of participants who receive hands-on training on a cyber range;
- Total number of participants who earn an industry-recognized credential;
- Total number of participants who complete training; and
- Total number of participants placed into unsubsidized employment.

Applicants may offer other metrics they will track.



# Attachment B - Budget

- Template can be found on Accelerating Cyber Careers website.
- Note there are two tabs: Budget Summary Form and Estimated Quarterly Expenditure. Both must be complete.
- Do not remove the formulas that are built in.
- Be as thorough as possible in the budget narrative.
- Leveraged Resources may be cash or in-kind.



## Reporting Requirements

- Grantees will be required to track the ongoing progress of the training program on a **quarterly** basis.
- Monthly reports will consist of the following:
  - Narrative Report (programmatic)
  - Invoice (fiscal)
- Templates to be provided by Labor upon award
