- 2. Meeting Called to Order by: Executive Director Deborah Rappazzo, 10:30 AM

- 5. Executive Director's Report
 - 1. Introduction-Executive Director, Rappazzo, welcomed everyone to the Advisory Council meeting and extended a thank you to the staff of Mount Olivet Cemetery for hosting the meeting.
 - 2. Mount Olivet Cemetery-History, Events and Restoration Presentation by Ronald Pearcey, Cemetery Superintendent and Chris Haugh, Community Relations & Historic-Preservation Manager:

Council Member-Pearcey and speaker Chris Haugh provided an overview of events occurring at Mount Olivet Cemetery. One of the events is known as the Friends Group which started years ago. This group is made up of volunteers that have been helping to clean stones, provide tours and do restoration work in the cemetery for several years. Their work throughout the cemetery will be highlighted during a cemetery tour. A few of the achievements done by the Friends Groups are as follows:

- Friends Group: Clean stones approximately 8-12 stones per month
- Friends Group: Preserve records, the chapel, and memorials, which are in the front 3rd of cemetery. Some of the preservation work involves many of the records pertaining to fallen civil war soldiers. Many of these burials are due to the cemetery's location to the war.
- Mount Olivet Staff: Created "Stories in Stone" which is a monthly article about someone buried at their cemetery. It can be found on the cemetery's website (Mountolivethistory.com-Stories in Stone). Tours and Lectures can also be reserved for individuals, small groups, and large parties.

3. Sudden Losses, Inc. by Sherri Tee, Executive Director, "Behind-the-scenes glimpse into the activities of the charity and more"

Sudden Losses, Inc. is a 501 c3 that accepts and donates cemetery rights (burial plots and burial goods and services) to families that have an unexpected death or are in need. Their website is "suddenlossesinc.com" which is currently under construction. They have no real budget; therefore, a lot of items are paid for by Ms. Tee. The nonprofit is looking for more volunteers. Information regarding the organization can be found on the IRS website. Information is not shared outside of the organization. George Washington/Mt. Lebanon has donated 24 rights. Their current Inventory is constantly changing. If you would like to submit an inquiry, you can send an email to Sherri Tee. Organizations only donate burial sites, advises of the additional costs, but does not cover them. It is possible to exchange space for another location for some of the corporations. Life does not come with a remote control. Sometimes you must get up and change the channel. Organization pays the transfer fees out of pocket. 5-6 families per week are serviced. The organization is near Washington DC.

Proposed Bills:

There are 3 bill proposals that will be submitted by the Maryland Department of Labor on behalf of the Office of Cemetery Oversight. These are as follows:

- Updating final dispositions of cremated human remains
- Registered Sellers selling preneed cremation certificates.
- Abandoned Cemetery Fund

Council Member Zinner asked a question regarding religious cemeteries being able to utilize the abandoned cemetery funds to care for their cemeteries, will this be allowed. Also stated that this bill appears to be a back door to regulating religious cemeteries. The Abandoned Cemetery Fund would potentially be for all abandoned cemeteries with funding provided by an optional \$1 donation on state income tax forms. This donation request may appear on Maryland State 2025 Tax form. Therefore, the OCO will have time to put a plan together to manage the passing of this bill. Council Member Zinner asked that once the bill has been passed, will another advisory committee be formed? Executive Director Rappazzo responded that that would be very helpful and should be discussed in greater detail at a later meeting.

Regulation Amendments:

There are a few regulation updates that have been submitted for consideration. They are as follows:

- Increase contract fees to be increased from \$15 to \$30 to manage the rising operation cost of the Office of Cemetery Oversight and improve services for licensees and constituents.
- Updating current regulations to include pet cemeteries.
- Creation of a regulation requiring applicants, licensees, and all others subject to the
 jurisdiction of the Office of Cemetery Oversight, to respond to communications when
 requested within 30 days. The new regulation would also require a person to notify the
 Office of a change in address. Lastly, pursuant to the regulation the failure to respond
 within 30 days may be considered a violation of Business Regulation Article, Title 5,
 Annotated Code of Maryland. A regulation to change initial and renewal permit fees for
 nonprofit cemeteries not actively selling burial plots or burial goods.

Process is to accept advisory council thoughts, then they are submitted to the Secretary, Secretary selects which regulations will move forward.
