Mr. Chenowith reported the following on behalf of the Incident Committee:

**Incident # 03-BP-24** - Remains open, pending review by Federal agencies. **Incident # 01-BP-25** - Remains open, pending review by Federal agencies.

## PILOT COMPLEMENT REPORT

Captain Nielsen reported the following:

Arrivals – Down by 6%

Shifts – Up by 13%

Cargo – The data shows 2024 was the second highest ever reported for total foreign cargo.

Retiring Pilots – The average predicted retirement age is 63 and a half. The Association anticipates the retirement of 3 pilots this year.

PIT - 4 PITs were recommended to start on July 1, 2025.

**Motion (II)** was made by Capt. Nielsen, seconded by Chair Steeves, and unanimously carried by the Board to approve the gradual increase in the number of licensed pilots as shown on the Proposed Pilot Complement graph. The aim is to manage an anticipated increase in ship calls to the new Sparrows Point Container Terminal which is scheduled to open in 2028.

**Motion (III)** was made by Chair Steeves, seconded by Mr. Derby, and unanimously carried by the Board to approve 4 PITs to start on July 1, 2025, as recommended by Capt. Nielsen.
