# **APPROVAL OF MINUTES**

For MPIA purposes the Minutes of the Meeting for January 6, 2023, were unanimously approved last January 13, 2023.

### **INCIDENT COMMITTEE REPORT**

Mr. Chenowith reported the following on behalf of the Incident Committee:

**Incident # 01-BP-23 -** Still open and pending further review.

**Incident # 02-BP-23 -** Open and was forwarded to the US Coast Guard for additional investigation.

#### PILOT COMPLEMENT REPORT

Captain Nielsen reported the following:

Arrivals – Up 6% YTD.

Shifts – Up by 6% YTD.

Cargo – the data for the year 2022 will be provided probably in May.

Retiring Pilots – 1 pilot already retired and probably 2 more later this year.

Pilot in Training (PIT) - 2 PITs started last Feb 1, 2023, as recommended in October 2022 Meeting. The committee recommends 4 more PITs to start in July of this year. It was also suggested to have 2 PITs to start early next year and 2 PITs in the second half of the year.

Motion (I) was made by Capt. Nielsen, seconded by Chair Steeves and unanimously carried by the Board via roll call to approve 4 PIT candidates to start on July 1, 2023, based on the data received from the Complement Report.

The Committee agreed with Commissioner Morgan when he asked to clarify that 4 PITs will start this year and 4 more PITs probable in 2024.
