Upon review of the record in this case, the Board of Appeals adopts the facts and reasoning contained in the decision of the Hearing Examiner.

The Board notes that any tips which are reported to the I.R.S. will be considered taxable wage under new legislation (House Bill 318; Chapter 197, Laws of Maryland, 1986). Unfortunately for the claimant, this legislation is not effective  $^{\rm 1}$  until January 1, 1987.

## DECISION

The claimant is not entitled to a higher or greater weekly benefit amount within the meaning of Section 3(b)1 of the Maryland Unemployment Insurance Law.

The decision of the Hearing Examiner is affirmed.
